#### MEMORANDUM

#### **RE:** Procedures for Council's Organizational Meeting

This month, we will have 2 Council meetings the week of April 15<sup>th</sup>. We will have our regular meeting on Monday April 15, 2024, and this will be the last official working meeting for the 2023/2024 Council. Then on Tuesday April 16, 2024, we will have the Organizational meeting which will be the first meeting of the 2024/2025 Council. This will also include a ceremonial transfer of power to the new council and recognition of the outgoing mayor and alders.

At Tuesday's meeting, Mayor Douglas will call the old Council to order. We will then honor any exiting Alders for their service to the City. Mayor Douglas will then adjourn sine die (basically adjourning the 2023/2024 Council and all pending motions are effectively terminated). The Clerk will then swear in the newly elected mayor and alders and they will sign the official documents. Mayor Douglas will resume as chair and will call for roll call of the new council. The new council will then proceed to select a Council President, take up alder appointments, and appoint an official newspaper.

<u>Here is the process for selecting a Council President</u>: The mayor will open the matter for nominations. Any alder can nominate another alder or even nominate himself or herself for the position. This is not a normal motion and therefore, no seconds are necessary. After all nominations are made, then the mayor will call for a motion to close nominations. This motion to close nominations would require a second and then the council will start the voting process. When voting for Council President, this is the one situation where alders can vote in secret. If the Council has only nominated 1 individual for the position, then the Council should vote in public for that nominated individual. If we have more than 1 nomination, this is where the vote could be tricky. Voting will be done by small ballots whereby you will write the name that you are choosing to be Council President. The Clerk will collect and count the ballots. If we have multiple nominations or tie votes, then the following rules will apply:

- 1. If there are 2 or more nominations and any alder receives the majority of votes cast (i.e., 5 or more votes), he or she shall be declared to be winner;
- 2. If there are 2 nominations and it ends in a tie, we will re-vote. If the 2<sup>nd</sup> vote also ends in a tie, we will then be at an impasse and the Mayor will cast the deciding vote;
- 3. If there are 3 or more nominations, but no one alder obtains the majority of votes cast, then the alder receiving the lowest number of votes is dropped and the Council re-votes (for example, one alder gets 4 votes, 3 votes for another and 1 for the last alder, since there is no majority, the alder with 1 vote would be dropped and the Council re-votes between the other two). If there are 4 nominated individuals and they each get the same number of votes (i.e., each get 2 votes), then the Council would have to re-vote.

<u>Here is the process for appointing alders to the various committees</u>: For the appointments of alders to the 6 standing committees (Board of Public Works, Finance & Tax, License, Judiciary & Ordinance, Public Safety, and Salary & Personnel), the mayor will decide which alders are on each of the committees and

whom will be the chairperson. Pursuant to Section 1-5-6(B) of the Monroe Code, there is no confirmation by the Council for these appointments. The mayor will then present her list of all other appointment to the other committees, commissions, boards, etc. and the chair designations. Pursuant to Section 1-5-6(E) of the Monroe Code, this second set of appointments by the mayor does require Council confirmation. So, the Council will need to move to accept the appointments as presented (or a subset of the appointments).
